#### DESCRIPTION

This is an agreement between you, the end-user, and Unified Theory Of Everything (UTOE), located at 314 The Grand, 1 Aytoun Street, Manchester M1 3DA, UK. In accepting the terms of this agreement, you, the end-user, acknowledge understanding and promise to comply with its terms. If you do not accept the terms, please do not complete the download.

DO NOT share, distribute, request illegal copies of, download via the internet or hardware, steal from a licenced user or re-sell UTOE fonts. We ask that licencees of our fonts respect our EULA and the amount of work that has gone into producing the font software.

The main points of our font licence are as follows:

# NON-COMMERCIAL LICENCE

The Non-Commercial licence (£40.00) is for personal work only and not to be involved in any manner with paid or commissioned work, whether for oneself or a third party. This excludes work of a charitable nature where work is done not for commercial gain, not for profit, and free of charge. UTOE reserves the right to contact the end user and/or the associated party/charity where such charitable work has taken place in order to certify the nature of the work, and or legal action if required. If you wish to use the font(s) for commercial use and / or practice, please download the Commercial licence. If you do not accept these terms do not download.

#### THE COMMERCIAL LICENCE

The Commercial licence (£80.00) permits commissioned and commercial work. All rules stated above apply except that this licence permits all work done for commercial gain, profit, and commissions with the exception of work done for any political parties and / or of a political nature. The font(s) are also not to be used for in corporate identity and or brand identity commissions (such as logos, marques, logotypes, or other registrable form) without first gaining permission from UTOE. If you do not accept these terms do not download.

# COPYRIGHT

Purchased fonts will remain copyright to UTOE and their creators.

### PRICING

We believe our pricing strategy is accessible for all. Our fonts are individually priced relating to their designer, use and availability. We reserve the right to increase and decrease prices of font software as we see suitable. In certain instances proceeds from the sale of certain fonts will go to assigned causes / charities / organisations.

REPLACEMENTS	If UTOE software is misplaced or stolen from a licenced user, we will happily replace the fonts to the licencee. The licencee must give the full registered name and email address which matches the previous transaction. We reserve the right to not re-supply font software we think is being used for illegal purposes.
USERS	Purchase of a font is for a single user. The purchase of a font makes the buyer a licenced user of the font, not an owner. The font may be loaded on to a maximum of 3 personal computers belonging to the same person or organization at a single location. Font licences are non-transferrable and are licenced to the original buyer unless previously agreed. Multi-user licences are not available and are for personal use only
THIRD-PARTIES	Fonts are allowed to be passed onto a pre-press service or printer for output only. Contractors are not allowed to actively create new documents with fonts that have been passed on for output only. If any modification is to be made by a non-licencee then a new licence must be purchased for that user. Selling, lending or hiring font software is strictly prohibited.
RETURNS	Unfortunately, we cannot offer returns or exchanges on our fonts due to their digital nature, unless the product is defective – in this case, we are happy to give technical assistance. Please contact us for support.
EMBEDDING	Embedding of UTOE font software in other software or devices or in any other form whatsoever is not permitted under this licence and is governed by a separate licence agreement. Please contact us to discuss.
MODIFICATION	The fonts/typefaces are our copyright, and licensing does not permit you to modify the fonts for your own purposes, or to execute modifications of our fonts for third parties. You may not modify, or commission a third party to modify, the fonts without first gaining permission from UTOE. You may not sell or give away modified versions of the fonts. Selling, lending or hiring font software is strictly prohibited. We do not allow users to make modifications to our fonts. You must contact us to discuss any modifications as a bespoke project.
RESPONSIBILITIES	Although every effort has been taken to check these fonts for viruses, in no circumstance what-so-ever do we take responsibility for damage caused to a user's hardware, software or a loss of income that may have occurred as a result. All UTOE software installed is done so at the owner's risk and we, UTOE, will not be held responsible.
TERMINATION	Any breach of the terms of this Agreement shall be cause for termination. In the event of termination, if applicable, you agree to immediately return the Font Software to UTOE and certify that no copy remains in your possession or control.
